

### PUBLIC NOTICE RE CORONAVIRUS(COVID-19)

# Court Actions to Mitigate the Spread of Contagious Illnesses and Address Public Concern Regarding COVID-19

It is the responsibility of this court to ensure equal access to the legal process which includes the right of all visitors to the Siskiyou County Superior Court access to our courthouse without fear they may become exposed to contagious illnesses. This document is published to advise of the actions implemented by court administration to ensure the safety of our courthouse and the health of its visitors. While this policy statement relates directly to recent concern regarding a new strain of the coronavirus, COVID-19, the procedures outlined herein will protect against the spread of contagious illnesses generally.

### What is the Coronavirus?

Coronaviruses are fairly common viruses that are found in the general population. The current strain of coronavirus, COVID-19, is different because it is a new strain for which a vaccine is not currently available, and the majority of the general population has not developed antibodies.

## What is the Siskiyou County Superior Court doing to mitigate the spread of all contagious illnesses, including COVID-19?

Court administration will have continuing contact with the Siskiyou County Department of Public Health and will follow the best practice recommendations of those public health officials. The courthouse, including all public areas are cleaned regularly. To reduce the spread of illness our building maintenance staff has emphasized the disinfecting of all areas within the courthouse.

It is recommended that Court visitors adhere to the following procedures:

1. Frequently, throughout the day, wash your hands with soap and warm water for at least 20 seconds;

2. Avoid touching your eyes, nose and mouth with unwashed hands;

3. Avoid close contact with persons who are sick;

4. Follow the guidance of your doctor or public health officials.

If you are sick with respiratory symptoms, a fever, or a cough; you may postpone your visit to the courthouse or request a continuance of your hearing. Please call (530) 842-0411 and pick the appropriate department to request a continuance. You can request to appear at your

hearing by telephone in some civil cases, please submit written requests by fax to (530) 572-4014. If your request is approved, it is your responsibility to contact Court Call, they can be contacted at 1-888-882-6878, arrangements need to be made at least two (2) days before a hearing.

#### What if I have received a jury summons to appear in court?

**If you are not sick**, you should report to the jury assembly room on the date and time indicated in your jury summons. Follow the five recommended procedures described above. You may consider bringing a small container of hand sanitizer with you to the courthouse as an additional precautionary measure.

It is emphasized that if you are sick with respiratory symptoms, a fever or a cough, DO NOT report to jury service. Contact the jury commissioner's office at (530) 842-0411, option #4 to request that your jury service be deferred to a future date.
